#### **ABOUT THE PROJECT**

The Faculty of Economics is implementing a Jean Monnet Centre of Excellence project, which has been awarded for the first time to a Montenegrin University by the European Commission. The project, called "The Challenges of the Enlargement Policy – EU vs. China's Diplomacy in the Western Balkans 2020-23" will run for the next three years. It will position the University of Montenegro and the Faculty of Economics as institutions capable of excellence in teaching and research in the fields of international relations, EU integration and other related issues, at both the European and the global level.

### Seminar 1: EU, CHINA AND THE WESTERN BALKANS: CHALLENGES AND PROSPECTS FOR FURTHER INTEGRATION

On May 27, the Faculty of Economics of the University of Montenegro, with support from the EU InfoCentre, organized a seminar "EU, China and the Western Balkans: Challenges and Prospects for Further Integration", which aimed to explore the geopolitical and geoeconomic roles of powerful players in the Western Balkans and their impact on Montenegro's European integration.

At the seminar, which was organized at the EU Info Center, with a live broadcast on the Zoom platform, Ambassador of the European Union to Montenegro Oana Kristina Popa addressed the participants by video message, and her Chinese counterpart in Montenegro, Liu Jin joined through the Zoom platform. An advisor to the Chief Negotiator with the EU, Dragana Markovic was also present, while the event was moderated by Danijela Jacimovic, Professor at the Faculty of Economics.

During the hour and a half of the seminar, mainly through the Zoom platform, Frank Schimmelfennig, a Professor at the Swiss Federal Institute of Technology in Zurich, Kong Tianping, a Professor at the Chinese Academy of Social Sciences, and Michael Kaeding, a Professor at the University of Duisburg-Essen, joined the discussion, as well as the President of the Atlantic Alliance of Montenegro, Savo Kentera.

Ambassador Popa assessed that the enlargement of the EU is by its nature a geopolitical issue, which implies investment in peace, stability and prosperity in Europe, as well as the strengthening of the Union

itself, Popa said in a video message. For example, investment projects must comply with EU standards in terms of procurement, public competitiveness, the environment, and energy or transport regulations. She added thatit was up to Montenegro and the region to manage their relationship with China to their advantage, while working diligently towards their main goal of EU membership. "This is a challenging task for policy makers, but a task that definitely benefits the Montenegrin economy and its citizens," Popa concluded.

The Chinese Ambassador, Luo Jin, said that the Western Balkans, China and the EU are open to enhancing cooperation and that this cooperation opens up many opportunities so that everyone benefits from it. He added that relations between Montenegro and China are based on the quality of mutual trust. He added that there is a benefit to both sides from the relationship, and that the political cooperation between Montenegro and China was greatly developed when China chose to support Montenegro's early accession to the EU. China has no geopolitical or other pretensions in Montenegro or the Western Balkans as a whole, nor does it want to compete with the European Union for influence in the region. China is open to cooperation with the EU in the direction of providing assistance to the countries of the Western Balkans, the Chinese ambassador concluded.

The Advisor to the Chief Negotiator, Dragana Markovic, said that Montenegro is following its European path, while cultivating good cooperation with global political and economic actors. What is much more important for Montenegro in the geopolitical balance of power is the fact that it is in the interest of our region to join the Union and that it is not only our interest but also the interest of the Union, said Markovic.
